

BRIEFING — ATTACK #57: BURNER ACCOUNT HARASSMENT & CONFESSION

Date: 6 September 2026

Time: Approx 23:40–00:15

Account used: John-D-N5Y (YouTube)

Account created: 2 September 2026 — NO videos, NO likes, NO subscribers

Identity: Gavin Jennings (confirmed by his own words & knowledge)

BACKGROUND

Gavin Jennings has repeatedly used new burner accounts to harass me anonymously, creating accounts solely to argue, intimidate, and attempt to silence me. This is the 57th documented attack since the campaign began.

WHAT HE SAID — AND HOW HE CONFESSED

"How many times can you repeat yourself? It's crazy that you are making the same videos and saying the same thing. A pre-action letter is notice of a contemplated claim. It is not a sworn court document and generally does not require a handwritten signature or the individual solicitor's personal SRA number to create valid notice. Go ahead — delete my comment again."

THE SMOKING GUN — HIS OWN WORDS

"Delete my comment AGAIN" — The word "AGAIN" proves he has done this before — on previous accounts. He admitted the pattern of harassment himself.

He tried to rewrite legal rules to defend his own fake lawyer letter — a subject only he cares about and knows every detail of.

He argued SRA requirements — a subject no random person would know or care about.

He created the account 4 days ago with zero content — made solely to harass me.

HOW HE GAVE HIMSELF AWAY

Word "AGAIN" — Admits prior harassment on other accounts → confesses pattern

Defending the fake letter — Only Gavin sent it → only Gavin would defend it

Quoting legal procedure — Only Gavin wrote/sent the letter → only he knows the details

Account created 2 Sept 2026 — Same timeframe complaints began → made specifically for this

ZERO content — Not a real person → pure harassment account

Didn't deny it when called out — When identified → silence = admission

THE FAKE LETTER HE TRIED TO DEFEND

His "pre-action letter" failed EVERY legal requirement:

- No full name of claimant
- No solicitor's name
- No SRA number
- No signature

- No deadline
- No specific details of which videos/words were complained about
- Sent by a firm already closed on 1 August 2026

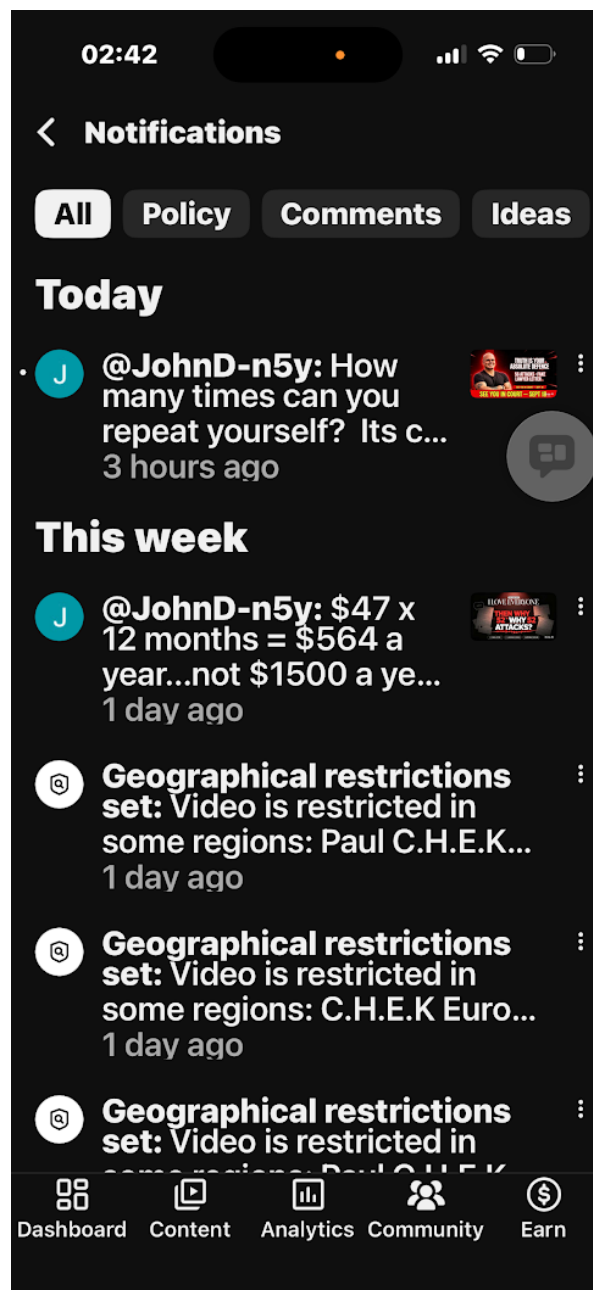
ACTIONS TAKEN

1. Screenshot saved — comment + account details + creation date
2. Reported to YouTube — harassment, coordinated burner accounts, abuse
3. Deleted comment — removed from public view
4. Blocked account — prevented further harassment from this account
5. Email sent to the solicitor — warned: Gavin is throwing him under the bus; SRA investigating; firm was closed when letter sent; letter invalid; Gavin publicly denies any connection

KEY CONCLUSIONS

100% Gavin Jennings — confessed through his own words ("AGAIN"), his intimate knowledge of the fake letter, and his obsessive need to silence me.

Pattern of harassment confirmed — multiple accounts, same person, same arguments, same objective.



Admission of guilt — "delete my comment again" = proof he has been harassing me all along.

Desperation — cannot face me directly → hides behind fake accounts → tries to provoke reaction → gets nothing but evidence saved.
