

BRIEFING — ATTACK #58: THREATS, INTIMIDATION & DISCRIMINATORY ABUSE

Date: 6 September 2026

Time: Approx 08:00–08:10

Account used: Burner account (new/unknown identity — Gavin Jennings confirmed by pattern, language, and prior admissions)

Identity: Gavin Jennings (Chek Europe / C.H.E.K Institute)

BACKGROUND

Following his admission on 5 September 2026 that he operates burner accounts to harass me ("delete my comment again" — Attack #57), Gavin Jennings has sent further messages from anonymous accounts. This is the 58th documented attack since the campaign began in 2013. This message contains direct threats to my livelihood, personal insults, and discriminatory language.

EXACT TEXT RECEIVED

"Congratulations - you have completely destroyed the remotest possibility that any member of the public would ever want to work with you as a client. You appear to be a sad, sorry, autistic specimen of delusion and hate."

NATURE OF THE ATTACK

1. **THREAT TO LIVELIHOOD** — Claims I have destroyed my ability to work with clients. This is an attempt to intimidate, financially damage, and coerce me into silence.
2. **PERSONAL ABUSE & INSULTS** — Uses demeaning language to degrade and attack me personally.
3. **DISCRIMINATORY LANGUAGE** — References a neurodivergent condition as an insult. This is hate speech and discrimination.
4. **REPEATED HARASSMENT** — Sent anonymously from a burner account. Part of an established pattern of over 58 incidents.

KEY OBSERVATIONS

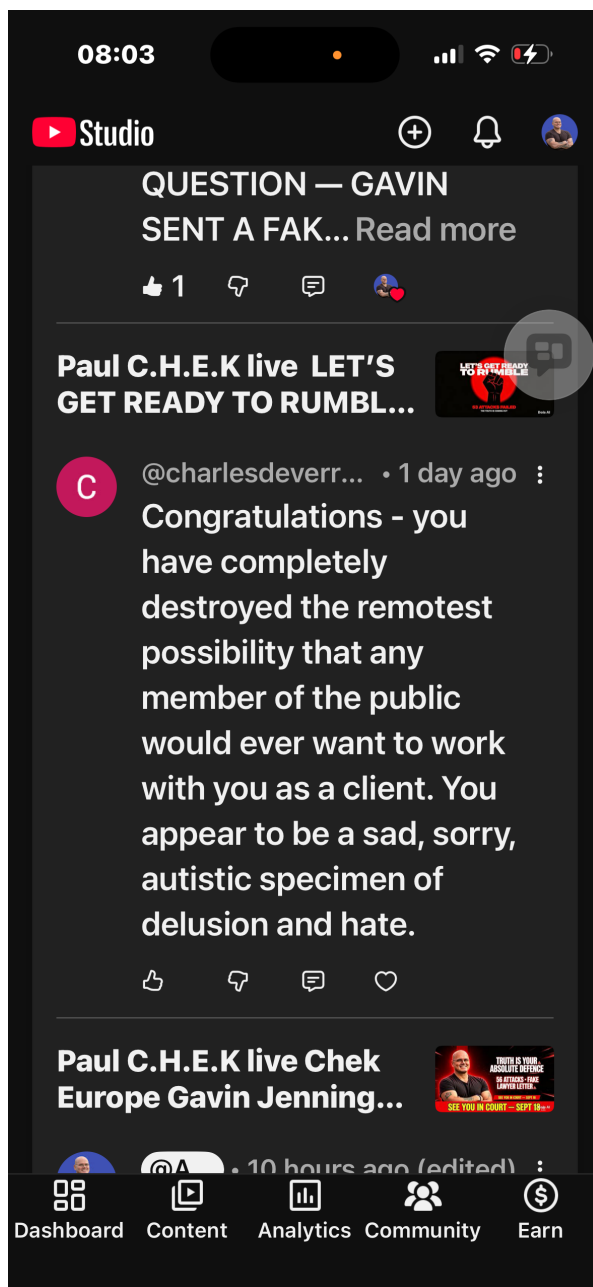
- **NO LEGAL ARGUMENTS, NO FACTS, NO EVIDENCE** — He has abandoned all pretence of a legitimate complaint. He now uses **ONLY** threats and personal abuse.
- **DESPERATION EXPOSED** — When he cannot win on facts or law, he attacks my business and my character. This confirms he has no defence.
- **HIS OWN WORDS CONDEMN HIM** — He threatens my livelihood, insults me personally, and uses discriminatory language — **ALL** from a hidden account because he is afraid to say who he is.
- **HIS BEHAVIOUR IS THE OPPOSITE OF HIS OWN TEACHINGS** — He publicly claims to teach love, integrity, and respect. Privately he threatens, insults, and demeans people from behind fake accounts.

ACTIONS TAKEN

1. Screenshot captured — timestamped, full message visible, account details recorded
2. Reported to YouTube — Category: Harassment & Bullying; Sub-category: Threats, Hate Speech, Repeated abuse from fake/burner accounts
3. Evidence emailed to myself — independent timestamped record secured
4. Message deleted by sender — confirms he panicked and tried to hide his own words
5. Account blocked — prevented from further contact via this account
6. Filed as ATTACK-58 — added to evidence folder for court

CONCLUSIONS FOR COURT

- This message is NOT legitimate debate or criticism. It is INTIMIDATION, THREAT, AND DISCRIMINATORY ABUSE.



- Sent from an anonymous burner account = HE KNEW IT WAS WRONG AND HID TO SEND IT.
- He deleted it himself = ADMISSION OF GUILT. He knew he went too far and tried to cover it up.
- Every threat and insult = ONE MORE COUNT in the pattern of harassment.
- He has NO defence, NO facts, NO legal argument — ONLY abuse and threats. This is what someone says when THEY KNOW THEY ARE WRONG and THEY ARE PANICKING.
